PEPERIKSAAN LEMBAGA JURUKUR TANAH - LISAN DAN PRAKTIK

Dengan hormatnya dimaklumkan Lembaga Jurukur Tanah telah meminda peraturan peperiksaan Lembaga untuk peperiksaan Lisan dan Praktik. Calun-calun dikehendaki :

- 1. Pass the subject "Laws and Regulations" in the Board's Examination ; and
- 2. Submit to the Board original field notes, relevant calculations and plans drawn therefrom of :
 - 2.1 The survey of a rural area of not less than 25 hectares, which shall coincide with and be reinstated from previous surveys; and
 - 2.2 The survey of a town lot with building on or near the boundaries.
- 3. Sit for the Practical Test

A Pass in an Oral and Practical Test on Cadastral Surveying which may be given at the Board's discretion. This practical test shall be as follows :

- 3.1 A candidate who has successfully completed his and field office training requirements and has passed all his practical assignments, is required to present himself on an appointed date to carry out the practical test under strict supervision by Examiners appointed by the Board.
- 3.2 The candidate will be required to carry out at least one task under each of the following tests :

Test 1 Adjustment and Use of Instruments

- (a) Chain Calibration;
- (b) EDM Field Test; and
- (c) Simple adjustment of theodolite/level.

Test 2 Field Practice

- (a) Planting mark on line;
- (b) Planting secant mark; and
- (c) Planting mark close to the instrument station at about 1 meter distance on a set bearing (Refixation method).

Test 3 Levelling

- (a) A Practical Test on levelling for a distance of not less than 1 km, starting from a Bench Mark and closing on to another Bench Mark.
- (b) Tacheometric survey of at least 5 stations picking up details of surrounding areas.
- Test 4 (18) Field Astronomy
 - (a) Sun observation morning observation
 - (b) Sun observation evening observation

Any other Test as may be prescribed by the Board.

4. The Practical Tests are to be completed within 2 days. Each test will be set a reasonable time frame. No extension of time will be considered except for reasons due to weather conditions.

 - 5.2 Passed the Lembaga Jurukur Tanah Laws and Regulations as in Para 1.
